

VIDEO SUBMISSION AGREEMENT

Thank you for your interest in Rainbow NEK. The following information contains the terms and conditions that define the agreement between you and Rainbow NEK when submitting video for broadcast.

- 1) For purposes of this agreement, the term *Video* will refer to any and all content, media and materials submitted to Rainbow NEK, including, but not limited to; still photography, writings, spoken statements, music, audio, video, slides, portraits, animated and/or motion pictures, caricatures, likenesses, vocal or other sounds, computer graphics, visual effects, as well as any accompanying documentation, packages or other materials submitted.
- 2) The rights, licenses and privileges described in this agreement are granted to Rainbow NEK beginning immediately upon submission of your video.
- 3) In connection with your submission of the video to Rainbow NEK under this agreement, you unconditionally and without monetary compensation grant to Rainbow NEK the right, license, authorization and permission to use, or to authorize the use of your video in whole or in part in any form or format. You also give Rainbow NEK, at its discretion, the right and authorization to remove, change or edit content from the video. Rainbow NEK reserves the right to refuse broadcast of submitted materials.
- 4) You must have full rights to comply with this agreement. By your signature you acknowledge that you have the rights, authorizations, permissions, approvals and consents to each video you submit.
- 5) Rainbow NEK is a "General" viewer broadcaster. By your signature, you acknowledge that you have carefully viewed your video and have removed, changed or edited any content that would not be suitable for broadcast on Rainbow NEK. Examples of unacceptable content include, but are not limited to the following: profanity; suggestive or derogatory remarks; racial gestures, suggestions, symbols, slurs or language; nudity; harmful acts to humans, animals or property; copyright or trade mark violations.
- 6) The storage device used to submit video must be clearly labeled using the same title and film date used on the agreement. For proper identification purposes and to release Rainbow NEK from liability, an <u>identifying credit must be present throughout the entire video</u>. This credit must identify the person(s) submitting the video. An example would be to place information, similar to the following, in the bottom left corner of the video in a font no smaller than 9 pts:

Submitted/Presented by: John Smith & Jane Doe

7) Rainbow NEK will make every attempt to broadcast approved submissions in a professional and timely manner. In most cases the video will broadcast as it was submitted, therefore quality is dependent on the person filming. Storage devices/Video will not be returned. Rainbow does not guarantee a time or date of broadcast. Approved submissions will be aired as the schedule permits.

Please fill out the this agreement completely. Incomplete submission forms will not be considered for broadcast.
